Guiding Principles

We believe that all our pupils have a basic entitlement to:

- High quality educational provision;
- Equality of access to a broad and balanced curriculum;
- Planned and systematic assessment of their attainment and progress;
- Appropriate / differentiated and planned teaching and learning to meet their individual needs.

Aims

In order to ensure educational inclusion of children with medical needs we will:

- Identify a named teacher to maintain an overview of the pupil's progress and needs, and to liaise with other partners (parents, carers, education, health and social workers);
- Once we become aware that a pupil has medical needs which mean they are unable to attend school, we will consult with the child's parent/carer about the nature of the condition, likely length of absence and support required;
- Notify the LA if a pupil is, or is likely to be, away from school due to medical needs, for more than 15 working days;
- Supply the appropriate education provider with information about a pupil's capabilities, educational progress and programme of work;
- Be active in the monitoring of progress and in the reintegration into school and liaising with other agencies, as necessary;



- Ensure that pupils are kept informed about school social events and are able to participate, for example, in homework clubs, study *Welcoming, Hardworking, Positive, Supportive* support and other activities;
- Encourage and facilitate liaison with peers, for example, through visits and video calls;
- Liaise with home and hospital teaching services to enable them to draw up an Individual Learning Plan to cover the education of a pupil likely to be at home for more than 15 working days and pupils with chronic illnesses who regularly miss some school;
- Consider the need for assessment of sick children, under the code of practice on the identification and assessment of pupils with special educational needs;
- Provide information about records of achievement and curriculum for individual pupils, as promptly as possible.

Responsibilities

- The governing body is responsible for ensuring that there is a named governor (Dave Ramsay) to maintain an overview, and the school has an up-to-date policy for the education of children with medical needs. This will be reported to parents at the Annual Parents' Meeting.

- The headteacher is responsible for implementing the policy and ensuring that staff are aware of their duties and take appropriate action.
- The teacher with responsibility for children with medical needs will be responsible for liaising with parents/carers and appropriate education, social and health service workers, monitor pupil's progress and help plan for return to school.
